**Fee Schedule:** \$3,000 per month, not to exceed \$15,000 over the term of the contract. Renewable for up to 12 additional months.

**Services:** Consultant will provide the following services to Client:

- Analyze Sports Museums locally and nationally and prepare discussion points relative to governance, funding and community associations in successful models;
- Analyze Sports Hall of Fames locally and nationally and prepare discussion points relative to governance, funding and community associations in successful models;
- Assist in the review of items currently contained in the collection;
- Provide strategic counsel to determine the most beneficial and cost effective outreach methods;
- Compile lists and proposals related to amateur sports in Orange County, including Olympians, college, high school and other sports teams;
- Develop proposals related to the marketing and promotion of HOF materials;
- Develop proposals related to the acquisition of new memorabilia by the Orange County Archives;
- Assist in the creation of an Annual Report Template;
- Provide advice and counsel on related projects as directed by the Clerk-Recorder.

Consultant will work closely with Clerk-Recorder but report to the Director of the Orange County Archives, and provide a monthly activity report to Clerk-Recorder. Consultant may also meet periodically with representatives of the Orange County Sports Hall of Fame Board of Directors (HOF).
